

## **ACCOMPLISHMENTS**

#### Unfair Government Competition with the Private Sector

- Provided legislative support to BCFC members and allies for their respective legislative and/or regulatory goals.
- Led efforts updating OMB's annual inventory of commercial activities and functions authorized under P.L. 105-270, the Federal Activities Inventory Reform (FAIR) Act of 1998.
- Co-hosted OMB policy roundtable at The White House on President Trump's Executive Order reorganizing the Federal government using the "Yellow Pages Test".
- Launched Coalition for the White House Conference on Small Business (WHCSB) given the 1995 WHCSB connection to efforts enacting the FAIR Act in 1998; led the introduction of H.R. 6446 in the 115th Congress.
- Testified on the "Yellow Pages Test" before President Obama's National Commission on Fiscal Responsibility and Reform (Bowles-Simpson).
- Opposed the Obama Administration's expansion of which governmental activities and functions are considered "inherently governmental" as compared to "commercial".
- Opposed the Obama Administration's "insourcing" of commercial activities and functions out of the private sector and into performance by the government workforce.
- Prompted the House Committee on Small Business hearing on "insourcing".
- Led the efforts seeking repeal of the moratorium on OMB Circular A-76 public-private cost comparisons.
- Coordinated victories on 5 recorded House votes on A-76 amendments.
- Testified on reforming A-76 before the House Committee on Oversight and Government Reform.
- Led efforts to introduce the Freedom From Government Competition Act (FFGCA) in the House and Senate.
- Organized numerous broad-based coalition letters to President Obama and Congress for implementing the "Yellow Pages Test" in legislation and regulatory options such as appropriations, NDAA, BBA, and OMB/OFPP action.
- Launched the Yellow Pages Caucus (YPC) in the House and held numerous staff meetings and Congressional briefings promoting greater reliance on the private sector by government at all levels.
- Led the efforts to introduce legislation reforming Federal Prison Industries (FPI) in the House.
- Testified on FPI Reform before the House Committee on Small Business.
- Testified on reforming the Unrelated Business Income Tax (UBIT) before the House Committee on Ways and Means.
- Co-hosted a special forum with the SBA Office of Advocacy focused on unfair nonprofit competition and UBIT.
- Co-hosted a policy roundtable with USAID featuring their private sector engagement (PSE) initiative.
- Identified \$795 Billion in Federal spending and policies generating an unlevel playing field for the private sector.
- Published over 100 editions of the e-newsletter 'Competition Watch' for BCFC members, Hill staff, and related allies.
- Published 2 Congressional "key vote ratings" scorecards based on recorded votes in the House and Senate.

## Public-Private Partnerships (P3s)

- Defeated a provision in the 2012 Highway Bill (MAP-21) that would have penalized states for implementing P3s.
- Promoted P3s in a letter to the House Committee on Transportation and Infrastructure special panel on P3s.
- Testified on P3s before the House Committee on Natural Resources.
- House YPC hosted several Congressional briefings on P3s.

#### **Government Owned Property and Assets**

• Won provisions improving the Federal real property asset inventory and disposal efforts in P.L. 114-318, the Federal Property Management Reform Act and Public Law 114-287, the Federal Assets Sale and Transfer Act, and DoD real property reform efforts in S. 2943, the 2017 National Defense Authorization Act (NDAA).
